NOTICE

The Wrestling Federation of India (WFI) has received a formal complaint against Mr. Rohit, S/o Sh. Devender, R/o Rainak Pura, Rohtak, Haryana - 124001, alleging multiple instances of falsification of personal information, including manipulation of date of birth and repeated unauthorized updates to his Aadhaar card. Upon thorough verification, the WFI has found the following:

<u>Aadhaar Card Manipulations:</u> Mr. Rohit, Aadhaar No. 6335 5115 8709, has made numerous unauthorized changes to his identity records as detailed below:

- 18/03/2013 Updated Aadhaar with Date of Birth: 17/10/1999
- 06/11/2016 Updated Aadhaar with Date of Birth: 17/10/2001
- 26/02/2021 Changed residential state from Haryana to Delhi
- 09/03/2021 Changed residential state from Delhi to Uttar Pradesh
- 12/04/2021 Changed residential state from Uttar Pradesh to Delhi
- 02/08/2021 Updated name to Rohit Gulia
- 15/09/2021 Changed residential state from Delhi back to Haryana

Date of Birth Discrepancy:

- Birth Certificate (Reg. No. 7554) issued by the Municipal Corporation, Rohtak, Govt. of Haryana, confirms Mr. Rohit's Date of Birth as 17/10/1999.
- However, he has falsely declared his Date of Birth as 17/10/2001 while participating in National Wrestling events.

<u>Misrepresentation in Competitions:</u> Mr. Rohit participated in the following events using falsified credentials:

- Represented Haryana in the 2019 Senior National Wrestling Championship held at Jalandhar (Punjab) from 28th Nov to 1st Dec 2019 in 79 Kg./FS
- Represented **Delhi** in 1st WFI Grand Prix Wrestling Tournament held at Haridwar (Uttarakhand) from 12th to 15th Nov 2022 in 79 Kg./FS.
- Represented Delhi Senior Ranking Tournament, Gonda (UP) from 21st to 23rd Jan 2023 in 79 Kg./FS.

The WFI considers these actions a serious breach of its code of conduct. In view of the evidence, the Federation has decided to take the following measures:

- 1. Mr. Rohit is hereby temporarily suspended from all wrestling activities under the aegis of the Wrestling Federation of India.
- 2. All achievements and participations in the above-mentioned events, obtained under false pretenses, are declared null and void.
- 3. Further disciplinary proceedings will be initiated in accordance with WFI's established rules and regulations.

The integrity of sport is paramount, and the WFI remains committed to ensuring fairness and transparency at all levels of competition.
