The Wrestling Federation of India (WFI) has received once again Birth Certificates of the following wrestlers:

| Leeza Rathee | Sh. Sunil Kumar | 23/08/2011 |
| Divya Phalswai | Sh. Gagan Kumar | 16/03/2008 |

Upon thorough verification, it has been found that all 04 wrestlers mentioned above have submitted birth certificates containing tampered or false information. The specific findings are as follows:

- Vijay (S/o Sh. Parmod): The Date of Registration on the submitted Birth Certificate has been altered.
- Vanshu (S/o Sh. Ravinder): This Registration No. MCDOLIR-0121-235484 mentioned on the Birth Certificate pertains to a male child born on 20/09/2021. It appears that this registration number has been used to generate a fraudulent or fake certificate.
- Leeza Rathee (D/o Sh. Sunil Kumar): A completely fake birth certificate has been submitted.
- Divya Phalswai (D/o Sh. Gagan Kumar): A completely fake birth certificate has been submitted. Upon verification and enquiry with the Office of the Cantonment Board, New Delhi, it has been officially confirmed that no such birth certificate has been found or registered at their center. This constitutes a clear case of submission of forged documents.

These actions represent a serious breach of the Wrestling Federation of India's Code of Conduct and undermine the integrity of fair competition.

The WFI views these violations with utmost seriousness and will initiate appropriate disciplinary proceedings against the concerned individuals in accordance with the Federation's rules and regulations.
