Sub: Selection Trials for U20 World Wrestling Championship - Slovakia

The 2026 U20 World Free Style, Greco Roman Style & Women Wrestling Championship, scheduled to be held in Bratislava [Slovakia] from 16th to 23rd August 2026. To ensure the selection of the best wrestlers to represent the country in this prestigious event, the Wrestling Federation of India (WFI) will conduct Selection Trials at as per the following schedule:

Selection Trials Schedule & Venue:

- On 15th July 2026 at 1000 hrs. at IG Stadium, New Delhi for Women Wrestling Team
- On 15th July 2026 at 1000 hrs. at RC, SAI, Lucknow for FS & GR Style Wrestling Teams.

Eligibility criteria for participation in the Selection Trials:

- All medal winners of the Under-20 National Wrestling Championship held in Bhilai (Chhattisgarh) from 10th to 12th April 2026.
- All medal winners of 2026 Senior Federation Cup held at Ghaziabad (UP) aged between 18-20 years.
- All medal winners of 2025 Senior National Wrestling Championship held in Ahmedabad (Gujarat) aged between 18-20 years.
- All medal winners of the 2026 Under-17 National Wrestling Championship held at Chhatrapati Sambhajinagar (Maharashtra) whose age is 17 years.
- All medal winners of 2026 U23 National Wrestling Championship scheduled to be held in Rohtak (Haryana) from 10th to 12th July 2026 aged between 18-20 years.
- The age of all participants will be verified before they are allowed to participate in the trials.
- The weigh-in shall be conducted at 0700 hrs. on the same day as the trial.
- As suggested by the Chief Coaches, weight tolerance of 1 kg will be allowed for the first five weight categories and 2 kg for the upper five weight categories, across all styles.
- The Selection Trial will be supervised by the highly qualified Technical Officials.
- All participants must carry their passport and recent photographs. Entry to the trials will be denied without these documents.
- Past performance (including results from 2025) will not be considered.

The following wrestlers are also eligible to participate in the U20 Selection Trial. However, they have been selected to compete in the 4th Ranking Series and will be in Hungary during the scheduled trial. Therefore, it has been decided that the wrestler who secures first place in the respective weight categories during the U20 Selection Trial will compete in a final trial against these wrestlers upon their return to India.
